

Privacy Policy

Introduction

Exalt Solutions, Inc. ("Exalt" or "we") takes your privacy seriously. Our primary goal in collecting information from you is to provide you with a favorable experience while you use our services. The purpose of this privacy policy is to explain how that information is collected, used and protected. Exalt may change this Privacy Policy at its discretion at any time, and information collected from you or your company is subject to the Privacy Policy in effect at the time of its collection.

Exalt may also collect contact information users voluntarily provide to permit us to contact them. This may include name, company, email address information, telephone numbers or related information. This kind of information is collected, for example, on the "Contact Us" page of our web site.

Finally, our web site, like many web sites on the Internet, collects the IP addresses of visitors and technical information, such as type of computer and type of web browser used and pages viewed and when you visit our Sites. This allows Exalt to analyze aggregate data regarding the web site, and improve our users' experience accordingly.

Other Sites

This web site may contain links to other sites outside the service. We are not responsible for the privacy practices of such other sites. We encourage you to be aware when you leave this site and to read the privacy statements of each and every web site that collects personally identifiable information. This privacy statement applies solely to information collected by Exalt.

How We Use The Information We Collect

Information the web site collects automatically from visitors, such as users' IP addresses, is used in the aggregate by Exalt to analyze use of the web site and the Services. Exalt does not disclose or sell such information, except in aggregate form, or as Exalt determines in good faith that the law so requires.

Account-related information, such as customer contact and billing information, is used by Exalt in connection with the provision of services to its customers. Occasionally, this information may also be used for marketing purposes, to make our customers aware of services our partners we believe they may find helpful.

Information that customers provide to Exalt in connection with their use of the Services belongs to those customers, although Exalt retains the right to retain and use that information in connection with the operation of the Services or web site, to provide customer support or technical assistance to customers, to apprise customers of information it believes they may find helpful (such as information about other Services that may be purchased separately from Exalt). Exalt will not disclose designs, sales proposals or similar personal information created by an Exalt customer with the Services to any third party (except as provided in the "Other Parties" section below) without the prior permission of the customer. Additionally, Exalt reserves the right to disclose any of the information collected if requested by a law enforcement agency or if it believes, in good faith, that the law requires it.

Finally, Exalt may be involved in mergers, acquisitions, assets sales or other business transactions. In these transactions, customer information generally is one of the

transferred business assets but remains subject to the promises made in any pre-existing privacy notice (unless, of course, the customer consents otherwise). So, your information may be transferred to a new entity in connection with a business transaction,[[or subject to review by participating entities in contemplation of such a transaction,]] but the terms of this privacy notice would otherwise apply.

Other Parties

Exalt may partner with another party to provide specific services to us or to our customers. These parties are not allowed to use customers' information except for the purpose of providing the services, or as otherwise specified in this Privacy Policy, or as may be specified in a privacy policy applicable to such services.

Security

Exalt uses industry-standard technologies to maintain the security of information it is provided by its customers. In spite of this, however, we cannot guarantee that such information will remain private and secure.

Cookies

When you connect to our web site, we may place a cookie on your computer. Cookies are small files, which are stored on your hard drive and not on our site. The use of cookies is an industry standard, used by most major web sites to improve their services. Cookies also help us track your use of our site so that we can tailor our web site and Services to better suit your needs. You can turn off cookies in your browser, but some parts of our site may not work properly if you do so.

Children and Privacy

Exalt does not provide services to individuals under thirteen years of age, and we do not intend to collect any personally-identifiable information from such individuals.

Notification of Changes

If we decide to change our Privacy Policy, we will post those changes on our web site so our users are always aware of what information we collect, how we use it, and information collected from our customers in a manner different from that stated at the time it was collected, we will notify those customers by way of an email. They will have a choice as to whether or not we use their information in this different manner. We will use information in accordance with the Privacy Policy under which the information was collected.
